MEDIA OUTLET AND CONTACT: Rubin, Joe - Sac News & Review

DEADLINE: ASAP for run this week

BACKGROUND: He is writing about the former indoor firing range in Sacramento. He says he thinks he's uncovered examples of improper inspections for lead contamination. This is one of a series of inquiries by this reporter. He has been told about the importance of a lead-sampling inspector being certified, definition of a lead-hazard investigation and that CDPH does not have a certificate for an alleged inspector that he has identified.

QUESTIONS:

Is there a record of certification for Jeff (Jeffrey) Hannah?

CDPH RESPONSE: CDPH did not identify a Lead-Related Construction certification for Jeff (Jeffrey) Hannah that would allow him to perform a lead hazard evaluation, including sampling for lead in paint, dust or soil.

Does a city employee have to be certified personally to collect lead samples? Or can a city train employees to collect lead samples?

CDPH RESPONSE: Per Title 17, California Code of Regulations, Sections 35001, et seq., an individual has to be certified by CDPH to collect lead samples as part of a lead hazard evaluation. A city that is not a CDPH accredited training provider cannot train employees to

collect lead samples for a lead hazard evaluation. Only individuals certified by CDPH can collect lead samples for a lead hazard evaluation.
